# PRESENTATION. Dr. Frederick Hellman.

### <u>OPIOID DRUG EPIDEMIC AND SUBSTANCE ABUSE INVOLVEMENT IN COMPLETED SUICIDES</u>. Some Highlights of his presentation:

- Poly Drug Abuse relationship to suicide.
- DELCO averages 70 suicides annually since 2008, prior average was 56.
- True numbers are higher, perhaps 90, most of the difference are in the undetermined category.
- Firearm deaths declining, however an increase in hangings and prescription overdose.
- #3 national cause of death are "Unintentional Injuries" (drug overdoses included)
- 2017 about 64K drug induced deaths. [2014 36,667 overdose deaths]
- He maintains gateway drugs are smoking & alcohol (16 to 25 times more likely to become addicted to drugs).
- THC (active ingredient in marijuana) causes death by malignant hypertension.
- Estimate that 2/3rds of deaths in DELCO are poly Drug Abuse.
- Chronic Suicidality results from high risk behavior.
- His presentation is still under development and research as he investigates the larger problems in the context of Delaware County.

• The spoke about the efficacy and options available for powerful new medications (*Invega Sustenna and Invega Trinza*) for treating schizophrenia. Chris Gibson and his Associate made the presentation.
